Tiffany Chu

Tiffany Chu is a designer, planner, and founder at Remix. She and her team based in San Francisco and Amsterdam, are working with over 350+ cities around the world to plan their transportation future. She's passionate about building livable cities and creating impact through user-centered design and technology. Previously, Tiffany was a Fellow at Code for America, partnering with the City of Charlotte to launch their first open data initiative. Tiffany is also an alum of Y Combinator, was the first user experience designer at Zipcar, wrote for Dwell, and studied architecture and urban planning at MIT. Anita Cozart is a Managing Director at PolicyLink where she leads place-based, equitable development initiatives. During her time at PolicyLink Anita has established the Transportation Equity Caucus, a national coalition that promotes policies that yield just and fair infrastructure investment; led a philanthropic partnership dedicated to expanding access to housing and opportunity; and served as a lead coordinator of Equity Summit 2015.
